- **The consent calendar was approved**, including the revision of the Curriculum and Academic Senate calendar for 2006.
- There was an update on the Compressed Calendar, which was overwhelming approved by adjunct and full-time faculty. It is scheduled to be implemented in the Fall of 2006. It is the understanding of the faculty that we would try to align the spring break with the Hart High School District. Also it was suggested that we consider, as a pilot, not having finals on graduation day. It was also suggested that we not have finals on the Saturday after commencement.
- **The Academic Freedom committee has a recommendation** that will be brought before the Senate at the next meeting. The concept of an "Ad Hoc" committee to resolve questions of Academic Freedom was discussed and received conceptual approval.
- **The College Hour Committee is meeting**. They are reviewing the college hour at five or six different colleges.
- **The "Community College Initiative**", is a potential ballot petition sponsored by FACC. A speaker will address the faculty on this issue in February.
- **Details on the Holiday Party** were shared by Michelle LaBrie. The Holiday Party is set for December 6, 2005 at 3:00 p.m. to 5:00 p.m. in the Performing Arts Center. Everyone is invited, and the cost will be around \$8. There will be a quartet doors will close at 3:15 followed by refreshments. .
- **Establishment of new Non-Credit disciplines** was brought before the Senate. Although the disciplines'; Minimum Qualifications were approved, it was decided to tabled the proposed.
- A brief report on the Statewide Academic Senate meeting was provided by Deanna Davis and Edel Alonso. They indicated that the event was quite an experience, and that they received a great deal of information. You can look at the statewide senate's webpage for a list of items and topics discussed.
- **The call for additional Curriculum Committee members** will be going out soon. The faculty recently endorsed the expansion of the Curriculum Committee to include three at-large members. Adjuncts are encouraged to be on this committee.

529.STUDENT CONDUCT

529.1 Introduction

The California Education Code (section 66300) requires every community college governing board to adopt specific rules governing student behavior along with applicable penalties for violation of such rules.

Students enrolling at College of the Canyons assume an obligation to abide by all College regulations

529.2 Grounds for Disciplinary Action

A student may be disciplined for one or more of the following causes which must be College/District related. This list is not intended to be exhaustive, but are examples of good and sufficient causes for disciplinary action.

- A. Any theft, conversion, or damage or destruction of and/or to any property, real or personal, belonging to the College, a member of the College staff, a student, or a campus visitor.
- B. Forgery, alteration or misuse of College documents, keys, records, or identification, or knowingly furnishing false information to a college.
- C. Cheating, plagiarism, fabrication, and other forms of academic dishonesty, and/or facilitating academic dishonesty.
- D. Physical or verbal abuse, including sexual assault, sexual harassment and stalking, or any threat of force or violence directed toward any member of the College or a campus visitor.
- E. Manufacture, use, possession, distribution, or being under the influence of alcohol, narcotics, or other dangerous drugs on campus, or off campus at any College-sponsored event.
- F. Unauthorized entry into, unauthorized use of, possession of, or misuse of, College property.
- G. Disorderly, lewd, indecent, obscene or offensive conduct on College-owned or controlled property of at College-sponsored or supervised function.
- H. Possession or use of any firearms, explosives, dangerous chemicals, or other potentially harmful implements or substances while on the College campus or at a College-sponsored function without prior authorization of the College President or designee.
- I. Failure to identify oneself to or failure to comply with directions of College officials acting in performance of their duties including, but not limited to, the provisions of the Penal Code Sections 626.6 and 626.8
- J. Obstruction or disruption, on or off campus, of the College's education process, administrative process, or other College function.
- K. Violation of any order of the College President, notice of which has been given prior to such violation and which order is not inconsistent with any of the other provisions of this policy. This notice may be given by publication in the College newspaper, or by posting on an official bulletin board designated for this purpose.
- L. Soliciting or assisting another to do any act which would subject a student to expulsion, suspension, probation, or other discipline pursuant to this policy.
- M. Abusive behavior directed toward, or hazing of, a member of the College community.
- N. Any other cause not listed above which is identified as good cause by Education Code Sections 76032 an 76033.
- O. O. Attempting to do any of the causes for disciplinary action identified above.

P. Abuse of computing facilities or computer time, including but not limited to unauthorized entry into a file to use, read, or change the contents or any other purpose; unauthorized transfer of a file; unauthorized use of another individual's identification or password; use of computing facilities to interfere with the work of another student, faculty member, or College official; and/or use of computing facilities to interfere with a College computing system. For specifics refer to the College of the Canyons Acceptable Use Agreement.

Proposed Additions:

- Q. Committing any act or engaging in any behavior that threatens or endangers the health or safety of another individual on campus or at any college sponsored activity or event:
- R. Willful misconduct that results in injury or death to a student or to College or District personnel or a campus visitor;
- S. Unauthorized preparation, selling, giving, transfer, distribution, or publication, for any commercial purpose, of any contemporaneous recording of an academic presentation in a classroom or equivalent site of instruction, including but not limited to handwritten or typewritten class notes, except as permitted by any district policy or administrative procedure;
- T. Gambling on College or District property;
- U. Willful or persistent smoking in any area where smoking has been prohibited by law or by regulation of the College or District;
- V. Failure to follow and comply with established guidelines and regulations for attending and/or participating in college-sponsored, off-campus activities including, but not limited to, conferences, retreats, field trips, excursions, internships, service-learning or volunteer placements, and athletic events.
- W. Violation of College or District policies or of campus regulations including those concerning chartering and registration of student organizations, use of College or District facilities, or the time, place and manner of public expression.
