Academic Senate Summary February 10, 2005

- **The consent calendar**, including Senate meeting summaries and the confirmation of John Albert as an Adjunct Senator, were approved with one minor topographical correction.
- The Commencement Review Committee gave an update on their discussion. A key issue was how to provide the faculty with the opportunity to become more involved with the ceremony. To help facilitate this, a faculty "honmor guard" as well as a post-ceremony "picture location" is being considered. Another topic of discussion was the increased security needs for the ceremony, particularly if we continue to hold it in the Honor Grove. There is also a discussion on instituting a "ticket" system as a possible way to help alleviate some security concerns caused by an influx of additional visitors.
- Lee Corbin's Celebration will take place on Tuesday, February 15, 2005, from 4:00 p.m. to 5:00 p.m. in the Cougar Den, with snacks provided by the Math/Sciences Division. If it rains it will take place in the lobby of the Performing Arts Center. We hope to provide an opportunity for individuals to share their favorite "Lee Story". People will be able to come up and give their story about Lee. In lieu of flowers donations can be made to a scholarship set up in Lee's name by his family.
- Curriculum Committee recommended that all courses required for majors must be completed with at least a grade of "C". Again, this change is only directed toward those specific courses required for a major. There seemed to be general consensus, however, a final vote will be delayed until February 24 to allow for additional discussion is needed.
- **Discussion on Academic Freedom** was initiated by the Senate. After a brief review of recent Academic Freedom "incidents" on two other campuses, the Senate opened its periodic review of the Board Policy for Academic Freedom. The board policy exists; however the written policy itself is not very physically visible.

It was suggested that, as part of this review, a FLEX presentation be scheduled on the topic of Academic Freedom. A subcommittee will be developed that includes all of the campus constituencies. Immediate volunteers included Sherrill Pennington, Fred D'Astoli, Dan Monteleone, Steven Vanover and Wendy Shaner. Additional personnel will be solicited.

Joan McGregor, Board of Trustee member addressed the Senate. She stressed that she was speaking as an individual member of the Board, not as the spokesperson for the Board. She mentioned that the Board was interested in opening up communications with the college community, including the faculty. She also mentioned that the Board would like to invite departments to make presentations to the Board about their departments – nothing long or very in-depth, more of a just a simple 5-minute presentation of "this is who we are and this is what we are doing".

Calendar Committee has representatives from Faculty, Administration, Classified, and Students. Mike Wilding gave a brief presentation on the possibility of a compressed calendar, as well as the possibility of a lengthened winter intersession.

Faculty members had raised some concerns and questions related to the implementation of a winter intersession. This full list was reviewed, with the understanding that there was not enough time immediately available to answer the questions. In addition, some of the questions were negotiable, and thus the Senate was not the correct forum to debate those concerns. These questions were noted to be valid concerns that should be addressed before a decision to implement a winter intersession is made. (Please contact Michael Dermody for a list of these questions).

In addition to the prepared concerns, the following additional concerns were raised as well:

- Would the TLC and tutors be available for intersession?
- Will the Cafeteria be available during the winter intersession?
- What impact would an intersession have on educational travel courses or the "Study Abroad" programs?
- What impact would an intersession have on the March 15 deadline for the faculty tenure process?

DISCUSSION ITEMS:

Proposal to require a C (not C-) or better grade in all courses required for the Associate Degree major. Rationale: As part of a continuous effort to upgrade the integrity of the Associate Degree, a recommendation was made by the Degree Audit Committee on January 13 to require that a C grade be required in all courses required for the major for the Associate Degree. This will make the Associate Degree major requirements equivalent to the COC certificate requirements in which students must earn at least a C in every course and the policy that most universities have that courses in the major must be completed with a minimum of a C grade.: Committee agreed to forward recommendation to Academic Senate

J. Jacobson Per Nancy Smith, Audrey Green is responsible for monitoring TOPS codes. In addition to reviewing Articulation needs in course proposals, she will be confirming TOPS codes are compliant with the Chancellor's Office requirements.

Patty Robinson commented on SLO on behalf of faculty. Concerns and confusion have been expressed by faculty. To remedy, Patty suggested C.C. make themselves avail be for direction. Joan suggested to reoffer Flex workshops. Patty encouraged committee to communicate that SLO are not Division Dean imposed but a new accreditation standard.
