## California Community Colleges Classified Senate

March 27, 2017

Dear Chancellors, Superintendents, and Presidents:

The California Community College Classified Senate (4CS) is happy to announce that they have received a Chancellor's Office Institutional Effectiveness Partnership Initiative (IEPI) Leadership Grant to develop a Classified Leadership Academy. The 4CS proposal is to identify a team from each of the 72 California Community College Districts to work on an equity-based project for that community college district. Each team will be led by a classified staff member who has been nominated by a chancellor/superintendent/ president (CEO) of a college or district and consist of a faculty member and a manager, selected by the applicant with the approval of the CEO.

The Classified Leadership Academy will take place on September 19-21, 2017, in Pacific Grove, CA. The classified staff leader from each of the 72 teams will be required to attend online informational meetings prior to and in preparation for the three-day intensive leadership academy.

As part of the academy, leadership development will address a broad spectrum of elements including, but not limited to, the importance of building consensus and developing strong leadership teams to better serve the important work of our community colleges. This will ensure all partners in our educational efforts find their voice in leadership.

After the training, classified staff leaders will meet with their team members to develop an equity proposal for which the entire team will be required to attend two one-day regional discussions, one in October and one in November, which will take place in 9 locations throughout the state. The team assignment requires the teams present their project and conclusions to their district Boards of Trustees, and develop a synopsis of the project for statewide awareness.

Training costs, lodging, and food are INCLUDED at no expense to the district or participants. The district is asked to cover the expense of travel (airfare, mileage, etc.).
