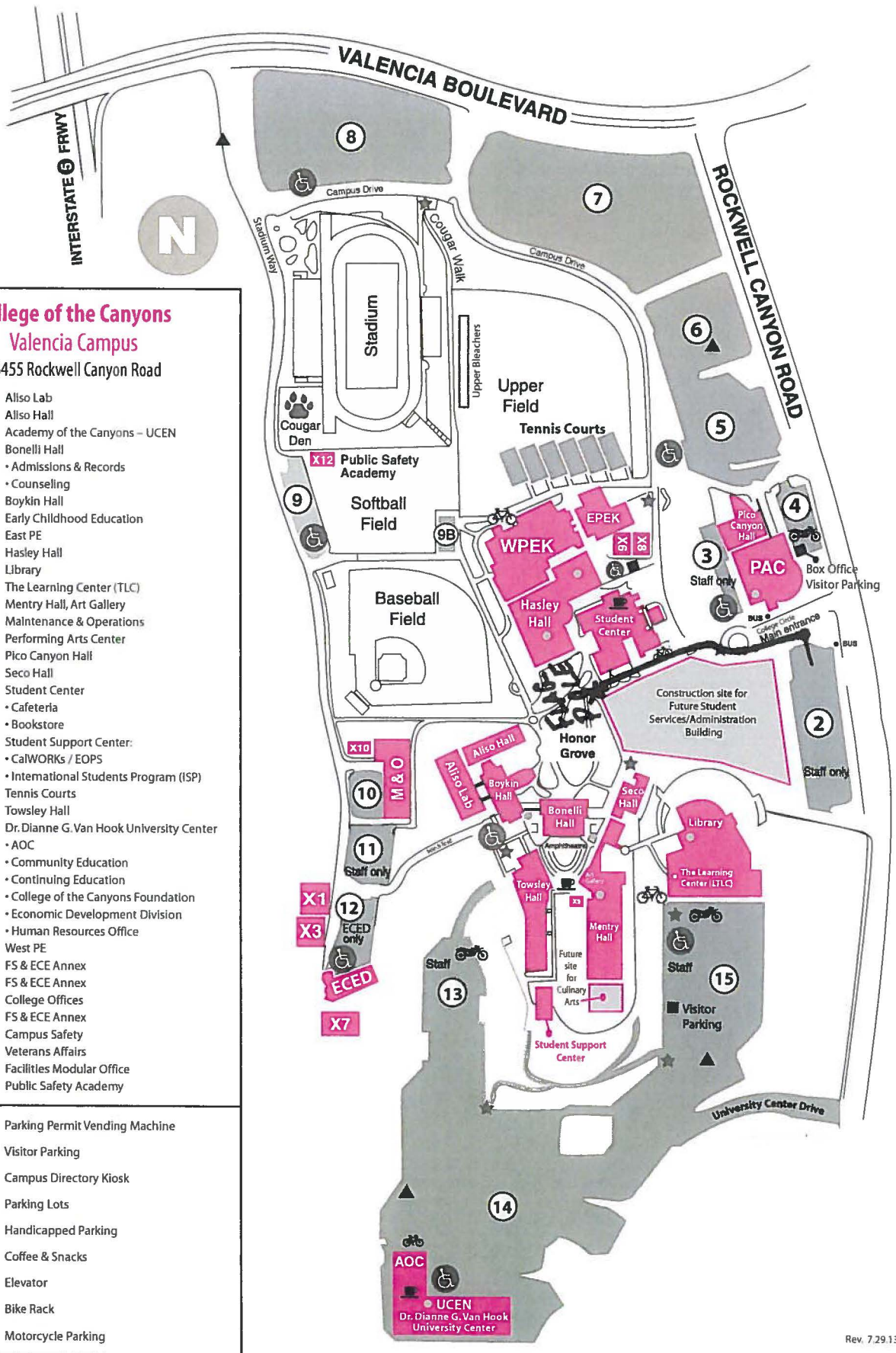

A quorum was declared and the meeting called to order at 3:00 pm by the Chair of the Oversight Committee, Mr. Lentini. Quorum Established (1.1)

The Committee moved approval of the meeting agenda. Approval of Agenda (1.2)

All guests were asked to introduce themselves.

The Committee moved approval of the October 22, 2013 meeting minutes. Approval of Meeting Minutes, 10/22/13 (1.3)
Motion: Hoskinson Second: Mellady Record of Vote: 6-0

Mr. Schrage provided a verbal update on the progress of construction projects on campus:

- Student Services/Admin building - all slabs have been poured on the second and first floors; concrete poured and metal studs will be added in the next week or two.
- There has been a lot of recent activity on the overhead "stuff."
- The Culinary building has completed their work on all underground activity, utilities and slabs.
- Steel beams will begin to be erected next week.
- The Culinary project is on schedule, and we have been fortunate to have good weather, which has helped keep everything on target.

Acceptance of Measure M General Obligation Bonds Financial Audit & Performance Audit for the Fiscal Year Ending June 30, 2013

Mr. Lentini thanked Mr. Schrage for his report, which was underscored by the group. Mr. Schrage announced that a tour of the SS/Admin building will be held after the meeting for anyone interested.

A letter from the CPA was in the packets sent out to all, validating the review of the audit. Ms. Coleal noted our auditors have conveyed their appreciation to the College, the staff and administration for everyone's help in making the audit compliance an easy process.

- Mr. Hoskinson noted he was very pleased with the outcome of this audit.
- Ms. Coleal underscored that we reviewed the audit in advance with the Board subcommittee, and it was very clean. The audit received an "unmodified opinion" from the auditors, which is the best option offered.
- The expenditures of the funds for Measure M are carefully reviewed, and Ms. Coleal noted our audit has "no exceptions" which underscores our careful use of bond money at the College. She noted COC is diligent about making sure we use these funds as approved by the guidelines for GO Bonds, and we are utilizing funds for projects that were approved by the voters for Measure M project.
- Ms. Coleal and Ms. Grandgeorge shared that we have remaining already issued bond funds from the first two issuances in the amount of \$21.9 million as of June 30, 2013.

Approval of Resolution 2013/14-01 Affirming the Santa Clarita Community College District's Compliance with Requirements as Stated in the Law (Section 15278-15282)
(3.2)

Mr. Lentini thanked Ms. Coleal for the report. He noted our auditors have confirmed, as noted in their report, that COC has properly accounted for the use of funds from the Measure M bond. There was a short question and answer period.

The Oversight Committee moved to approve Resolution 2013/14-01, affirming the District's compliance with requirements as stated in the law, and as noted in the financial and performance audit.

Second Hoskinson

Passed: 6-0

The Committee discussed the timeframe for their next meeting, and April was selected.

Dr. Van Hook stated that the committee will be asked to meet in approximately 3 months so that the District can provide information to this committee as to how we will issue additional bonds in August. She noted the Committee does not approve the plan, but the District wants to share it with them to keep knowledgeable about our efforts and plans.

Mr. Schrage noted he would be traveling to Sacramento later this week, and he is encouraging those at the state level to advocate for a facilities bond in the November election. Dr. Van Hook added that more students are coming to community colleges every year, and there is a lot of demand for access.

Mr. Lentini called for adjournment, and invited anyone wishing to take a tour to stay and join the group.

There being no further business, the meeting was adjourned at 3:37pm.

Following adjournment, Mr. Schrage and Dr. Van Hook led a tour of the Student Services and Administration building to view the progress of the Measure M-funded facility.

BACKGROUND / ANALYSIS:

In 2006, the District successfully passed a ballot measure, Measure M, to issue \$160 million in General Obligation Bonds.

In May 2007 the District issued \$80 million in Bonds against this authorization. In May 2012, the District issued an additional \$35 million in Bonds, leaving \$45 million of the initial voter approved amount available for issuance:

Original Voter Authorization	\$160 Million
First Issuance – May 30, 2007	(\$ 80) Million
Second Issuance – May 16, 2012	<u>(\$ 35) Million</u>
Remaining Authorization Available	\$ 45 Million

At this time the District has fully obligated all of the \$115 Million in bonds issued to date. In anticipation of moving forward with the next list of projects, a third bond issuance for approximately \$20 Million is being considered for Summer 2014. These bonds would be used to fund:

- New Construction
- Equipment
- Technology Infrastructure
- Modernization
- Accessibility Improvements

An overview of the projects to be funded by the third issuance will be provided at the meeting. The timeline for the G O Bond issuance, as well as the potential matching funds that may be available from the State, will also be discussed.

It is important to note that the District and its bond consultants also regularly review municipal bond market conditions and recommend refunding existing General Obligation Bonds when it will result in a savings to the taxpayers. In fact, the District refunded some of the outstanding Measure C bonds in February 2013 and provided over \$4.5 million in cost savings to our District's taxpayers.



BACKGROUND / ANALYSIS:

Life-to-date Expense Reports through March 31, 2014 are attached. **Expenditures** of bond proceeds as of March 31, 2014 totaled \$107,997,714. **Available funding** from Measure M as of March 31, 2014 included the proceeds of two GO Bond issuances and interest earned on project funds:

First Issuance – May 30, 2007	\$	82,599,991 (including premium bonds)
Second Issuance – May 16, 2012	\$	<u>37,577,125</u> (including premium bonds)
Subtotal - GO Bond Proceeds	\$	120,177,116
Estimated Interest through June 30, 2014	\$	<u>5,467,553</u>
Total - Available GO Bond Funding	\$	125,644,669

We estimate that Measure M GO Bond funds will be used to leverage another **\$67,563,000** in State match funding. We have earmarked the \$125,644,669 in available GO Bond funding for the projects listed below:


