#### **Discussion Items:**

-IDEAA Images. Jeremy Patrich and Julie Hovden reviewed the IDEAA images that they submitted that represent themselves and what the curriculum committee means to them.

-CSU-GE Area E.

Background: New CSU-GE Ethnic Studies requirement (Area F) approved in October 2020, effective Fall 2021. Area F submissions were due in December 2020 for them to be effective in Fall 2021.

5 <u>Core Competencies</u> were developed by CSU. For a community college courses to be eligible to Area F, 3 of the 5 <u>Core Competencies</u> must be reflected in the course outline of record. Course must also have an Ethnic Studies prefix to be eligible for Area F.

We submitted 12 courses in December 2020 that were approved for the previous Ethnic Studies section in Area D of CSU-GE...1 was approved (POLISC-290/ETHNST-290). We received these decisions in June 2021.

2 more additional course were submitted in the December 2021 window, "African American History to 1877" and "African American History Since 1877". Both were denied. The courses were then revised again to better meet the Area F core competencies, resubmitted and denied again.

After being told in 2021 not to use to the Area F <u>Core Competencies</u> word-for-word in course outline submissions, but rather infuse the competencies into the outline, we are now being advised to use core competencies word-for word in our course outlines. At least 3 of the 5 core competencies must be reflected in the Course Outline to be eligible for Area F

Course outline should read as Ethnic Studies courses...not like History, Sociology, English, etc. courses.

Textbooks/Readings examples should include Ethnics Studies readings. Recommendation from CSU: "CORs should include current textbooks/readings on ethnic studies, race and ethnicity, or race and racism in America. Classic or seminal works by Ethnic Studies scholars are encouraged. If the course focuses on any of the four core groups, please include Ethnic Studies texts by the discipline scholars."

Example Ethnic Studies texts from CSU:

Omi, M., Winant, H. (2014). Racial formation in the United States (3rd ed.). Routledge. Golash-Boza, T. M. (2017). Race and racisms: A critical approach (2nd ed.). Oxford University

-Cultural Competency Checklist. The Curriculum Committee began discussion on the Cultural Competency Checklist and how it should be used/represented in our course outlines of record.
