HIST-250	World Environmental History	History 250 would benefit a wide variety of COC students. First, it will benefit history majors by offering a new history course focused on an important methodology environmental history—not currently being taught at COC. It would also help fill a major gap in the department's current world history—curriculum, which, at present, lacks the second half of the—world history survey. The majority of History 250 will focus—on events since 1500, therefore, it will help remediate this problem. Second, History 250 would benefit students enrolled in the college's Environmental Science and Environmental—Studies programs by providing relevant social science or humanities credits and/or contextualizing the concepts—learned in each program.
