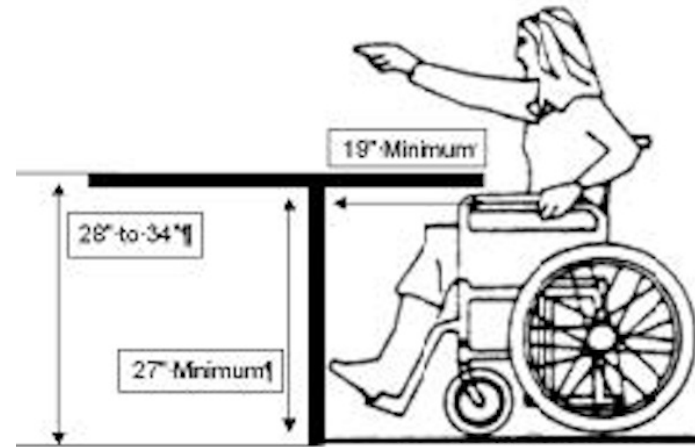
ADA-Compliant Table Dimensions

At least five percent of seating (and no less than one) must be a minimum of:

- 27 inches High
- 30 inches Wide
- 19 inches Deep

19 inches deep

Tables cannot exceed 34 inches in height.

- Finish: Charcoal laminate/edgeband, and silver metallic legs (or silver whatever is standard)

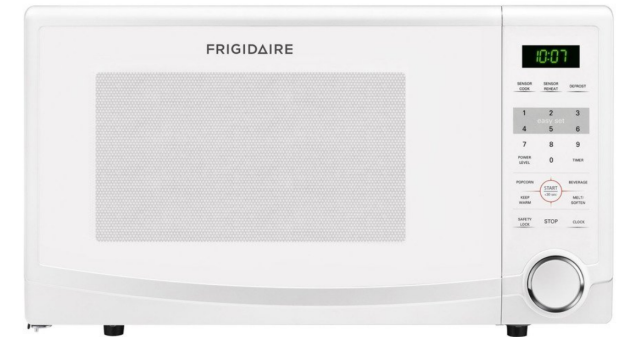
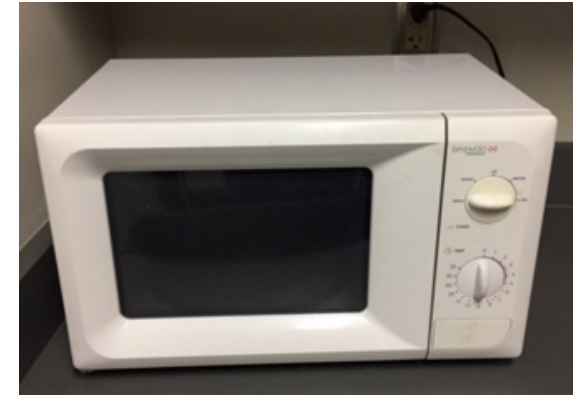
Photo Rooms 129,133 and Life Drawing Room 245

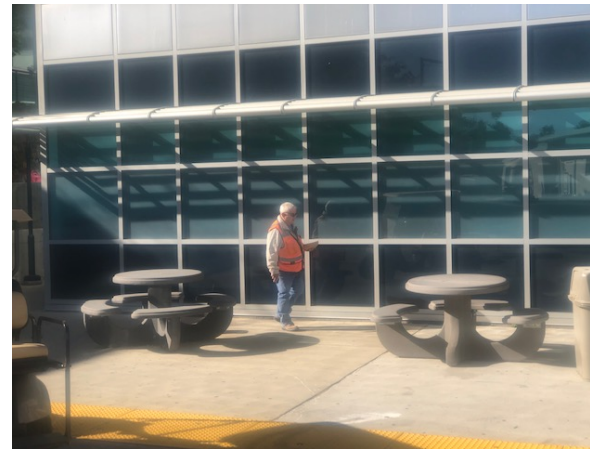

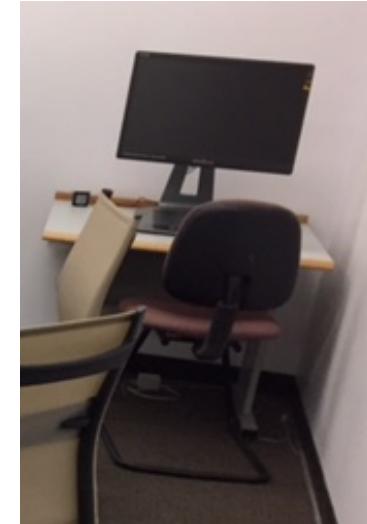

DSPS Department

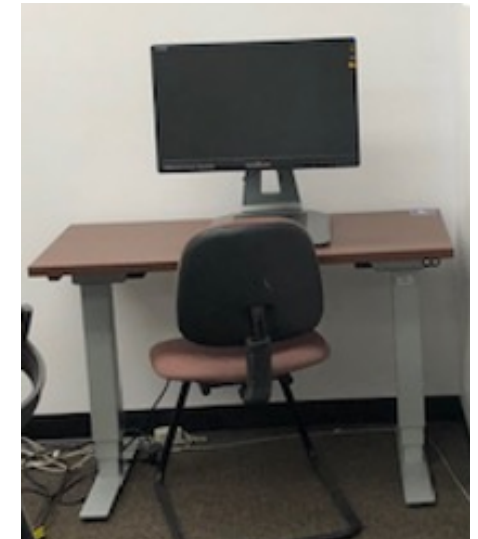
- Base infringing upon minimum depth & width

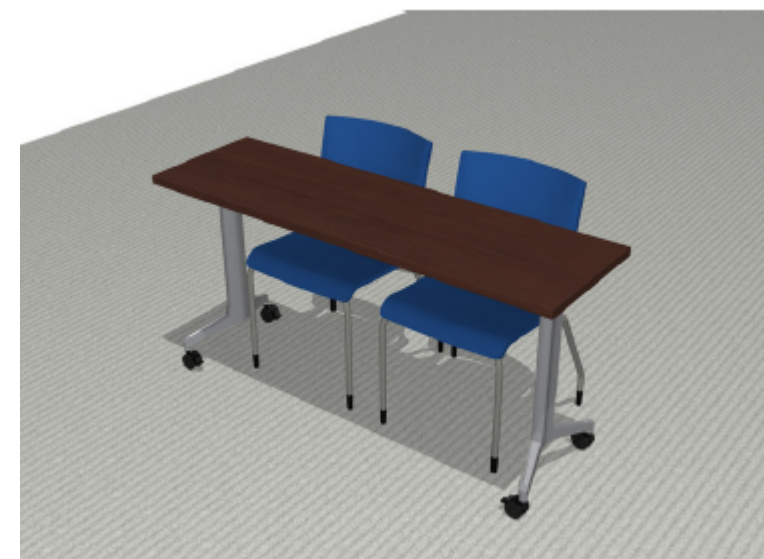
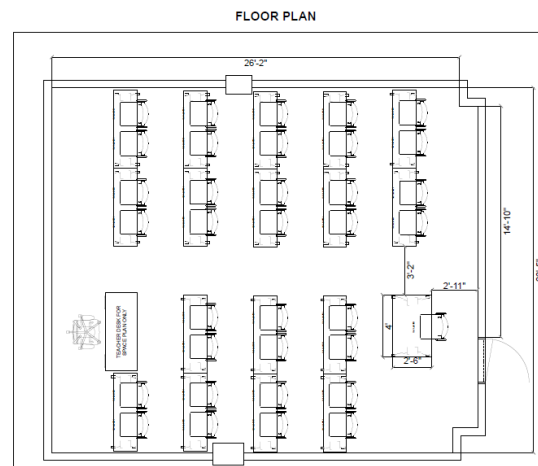
Classroom #108

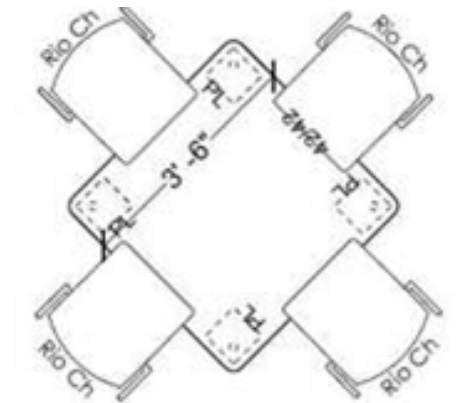
