3. Update on Student Equity & Achievement (SEA) 2.0 Plan Open Hours Meetings and Committee Brainstorming. Preeta Saxena/Vida Manzo/Jasmine Ruys (1 hour 10 minutes)

At the committee's September 13<sup>th</sup> meeting, we reviewed the College's Student Equity & Achievement (SEA) data for the 2022-26 SEA Plan due to the California Community Colleges Chancellor's Office in November 2022 and discussed existing programs, strategies and efforts supporting the SEA Plan metrics:

- Access/Successful Enrollment in the First Year,
- Completing Transfer-Level Math & English in the First Year,
- Persistence from First Primary to Subsequent Primary Term,
- Attainment of the CCCCO Vision Goal-Degree/Certificates- Within 3 years and
- Transferring to a Four-Year Institution

Deeper data dives into the disaggregated SEA Plan 2.0 data for each of the metrics were held following the 9/13/22 committee meeting with 30 faculty, staff and administrators over 12 hours.
