Background: In preparation for the ASG Elections Ballot for Spring 2022, the advisors reviewed the ASG Constitution (latest update was in 2015-2016). Updates to the ASG Constitution will be reviewed by the ASG Executive Board for the 1st reading so that all of the amendments can be approved by the student body during the upcoming Spring 2022 Elections.

-To summarize the changes is removing some outdated language such as requiring payment -of the Student Support Fee

-Also, updated gender-specific language, from he/she to this

-Executive Board was updated to Student Senate

-Added the officer of equity position information

-Updated the department name to Campus Life

-The ballot will explain the changes that were made as well as a hyper-link -Removed specific program names that were previously required as this senate has been very mindful

-Removed specific details for events as it does not cater to creativity of the officers

-Events will still be required but more generalized

-Removed language from section 7

-Removed the requirement to meet with Activity Board every other week

-ICC updated to say shall meet regularly except on school holidays

-Clause 8 and I – no clause for these positions and added.

-Removed the recognition days for staff and students

-Officer of Equity job description and will include the clauses for this position

-Article 8- legal language and refers to a supremacy clause which makes the constitution prevail over other documents. This is taken from the US Constitution and may need revamping of this phrase.

-Section 13 Section D should be a space in between inter and club -Page 3, Clause B- included the Officer of Equity under the line of seniority to take over as president and the order this new position would fall under -Clause B, section 6-Switch Executive Liaison with the Officer of Equity in the line of order

-Reword to "All other agreements and contracts" that replaces the outdated language ----"debts and contracts" at the end.
